THE COURT ORDERS THAT:

Pleadings

1. The date for the respondents to file and serve their defences, and any cross-claim, be extended to 22 March 2019.
2. On or before 4.00pm on 4 April 2019, the applicant file and serve any reply to the respondents' defences, and a defence to any cross-claim filed by the respondents.

Common fund and declassing applications

3. On or before 4.00pm on 1 April 2019, the applicant:
 - (a) file and serve his interlocutory application for a common fund order;
 - (b) file and serve any evidence and submissions on which he relies in support of that application.
4. On or before 4.00pm on 1 April 2019, any party wishing to make an interlocutory application pursuant to s 33N of the *Federal Court of Australia Act 1976* (Cth):
 - (a) file and serve the application;
 - (b) file and serve any evidence and submissions on which it relies in support of that application.
5. On or before noon on 3 April 2019, any party responding to an application made pursuant to orders 3 or 4 shall serve any evidence and submissions on which they rely.



6. On or before noon on 4 April 2019, the applicant on any application pursuant to orders 3 or 4 shall file and serve any evidence and submissions in reply.


Security for costs applications

7. The applications for security for costs dated 15 February 2019 be adjourned to 9.30am on 5 April 2019.
8. Leave be granted to the parties to file and serve short written submission on the question of the power to order security for costs by 22 March 2019.
9. Leave be granted to the parties to file and serve any note concerning the frequency or otherwise of the existence of non-funded industrial class actions by 22 March 2019.

Case Management

10. The proceedings be case managed, and the hearing of the initial trial to take place, in Sydney.
11. On or before 3 April 2019, the parties are to serve a list of proposed common issues or issues of commonality that should be determined at the initial trial.
12. Evidence in each of proceedings ACD46/2018 and ACD47/2018 be evidence in the other.
13. The proceeding be listed at 9.30am on 5 April 2019 in Sydney for:
 - (a) the hearing and determination of any application made pursuant to orders 3 or 4;
and
 - (b) further case management.
