THE COURT ORDERS THAT:

Pleadings

1. Order 2 of the orders made 15 March 2019 be varied to extend the time for the applicant to file and serve any reply to the respondents' defences, and a defence to any cross-claim filed by the respondents on or before 4.00pm on 10 May 2019.

Common fund and declassing applications

2. Order 3 of the orders made 15 March 2019 be varied to extend the time for the applicant to:
 - (a) file and serve his interlocutory application for a common fund order;
 - (b) file and serve any evidence and submissions on which he relies in support of that application,to 4.00pm on 17 May 2019.
3. Order 4 of the orders made 15 March 2019 be varied to extend the time for any party wishing to make an interlocutory application pursuant to s 33N of the *Federal Court of Australia Act 1976* (Cth) to:
 - (a) file and serve the application;
 - (b) file and serve any evidence and submissions on which it relies in support of that application,



to 4.00pm on 17 May 2019.

4. Order 5 of the orders made on 15 March 2019 be varied to extend the time for any party responding to an application made pursuant to orders 2 or 3 to serve any evidence and submissions on which they rely on or before noon on 24 May 2019.
5. Order 6 of the orders made on 15 March 2019 be varied to extend the time for the applicant on any application pursuant to orders 2 or 3 to file and serve any evidence and submissions in reply on or before 28 May 2019.


Security for costs applications

6. The applications for security for costs dated 15 February 2019 be adjourned to 12 noon on 17 June 2019.

Case Management

7. Order 11 of the orders made on 15 March 2019 be varied to extend the time for the parties to serve a list of proposed common issues or issues of commonality that should be determined at the initial trial on or before 28 May 2019.
8. Order 13 of the orders made on 15 March 2019 be vacated.
9. The proceedings be listed at 12 noon on 17 June 2019 in Sydney for:
 - (a) the hearing and determination of any application made pursuant to orders 2 or 3;
and
 - (b) further case management.
