THE COURT ORDERS THAT:

Confidentiality

1. Pursuant to ss 37AF(1)(b) and 37AG(1)(a) of the *Federal Court of Australia Act 1976* (Cth), on the ground that the Order is necessary to prevent prejudice to the proper administration of justice, until further order of the Court:
 - (a) those parts of the materials in Exhibit “NCB-2” to the affidavit of Neill Curtis Brennan affirmed 22 May 2019 that are redacted:
 - (i) are to be treated as confidential;
 - (ii) not to be disclosed to any person other than a Judge of this Court or Court staff,
 - (b) those parts of the materials in Exhibit “NCB-3” to the affidavit of Neill Curtis Brennan affirmed 12 June 2019 that are redacted:
 - (i) are to be treated as confidential;



- (ii) not to be disclosed to any person other than a Judge of this Court or Court staff.

Common questions

2. By 15 July 2019, counsel is to confer in order to agree questions of substantial commonality in each proceeding (**Merck orders**).
3. By 2 August 2019, the applicant serve on the respondents a list of the issues of fact and law that he seeks to have determined at the initial trial (**List of Issues**).
4. By 16 August 2019, each respondent serve on the applicant any proposed amendments (including additions or deletions) to the List of Issues.
5. By 23 August 2019, the applicant serve on the respondents any further proposed amendments (including additions or deletions) to the List of Issues.
6. In the event agreement is reached in respect of the Merck orders and the List of Issues, agreed lists and Merck orders in each proceeding are to be emailed by 29 August 2019 to the Associate to Justice Lee.

Request for particulars

7. By 31 July 2019, the applicant provide the particulars requested in:
 - (a) the letter from Herbert Smith Freehills dated 1 April 2019 to Adero Law requesting certain particulars of his Amended Statement of Claim dated 19 December 2018 and
 - (b) the letter from Herbert Smith Freehills dated 11 June 2019 to Adero Law requesting certain particulars of his Reply dated 23 May 2019.

Common File

8. Proceeding ACD46 of 2018 be designated the “common file” as between proceeding ACD46 of 2018 and ACD47 of 2018.



Further case management

9. The proceedings be listed for a further case management hearing on a date to be fixed.
