THE COURT ORDERS THAT:

Consolidation

1. Pursuant to r 30.11 of the *Federal Court Rules 2011*:

- (a) proceeding ACD85/2019 (*Simon Alexander Turner v Ready Workforce (A Division Of Chandler Macleod) Pty Ltd*) be consolidated with proceeding ACD47/2018 (*Simon Alexander Turner v Ready Workforce (A Division Of Chandler Macleod) Pty Ltd*)



(ACN 088 288 037) with the consolidated proceeding to bear the file number ACD47/2018; and

(b) costs in former proceeding ACD85/2019 be reserved.

Amended Pleadings and Lists of Questions

2. Within 28 days after delivery by the Full Court of its judgment in proceeding QUD724/2018 (*WorkPac Pty Ltd v Rossato*), the applicant serve on the respondents:
 - (a) any proposed further amended originating applications in proceedings ACD46/2018 and ACD47/2018;
 - (b) any proposed further amended statements of claim; and
 - (c) his proposed lists of questions to be determined at the initial trial;(together, the **Amended Pleadings and Lists of Questions**).
3. Within 14 days after service of the Amended Pleadings and Lists of Questions, the respondents deliver to the applicant any objections to the Amended Pleadings and Lists of Questions (**Respondents' Positions**).
4. Within seven days after receipt of the Respondents' Positions, the applicant file and serve any interlocutory applications (together with any affidavits in support) in respect of proposed amendments to the originating applications, and approach the Associate to Justice Lee for a date to be fixed for the hearing of the applications.
5. Not later than 10 days prior to the hearing of any applications filed pursuant to order 4 the applicant shall file and serve a written outline of his submissions in support of his applications, such outline not to exceed five pages.



6. Not later than five days prior to the hearing of any applications filed pursuant to order 4 each respondent shall file and serve a written outline of its submissions in respect of the applications, such outline not to exceed five pages.
