THE COURT ORDERS THAT:

Evidence

- 1 By 4.00 pm on 27 July 2018, the respondents give standard discovery in respect of the applicants' claims in accordance with FCR 20.14.
- 2 By 4.00 pm on 27 July 2018, in accordance with FCR 20.14, the respondents give discovery of the categories of documents identified in the letter from Shine to Allens dated 5 April 2018.
- 3 By 4.00 pm on 6 July 2018, the respondents are to provide a further interim tranche of documents produced in accordance with Orders 1 or 2.
- 4 Orders 18-23 made on 29 January 2018 be vacated.

Common Fund Application

- 5 By 4.00 pm on 15 June 2018, the applicants are to file and serve on the respondents:
 - (a) their proposed orders for an amended Court approved common fund order (**Amended Common Fund Application**);
 - (b) any further evidence upon which they propose to rely in relation to the Amended Common Fund Application; and




- (c) written submissions in relation to the Amended Common Fund Application.
- 6 By 4.00 pm on 22 June 2018, the respondents are to file and serve on the applicants:
- (a) any evidence in reply in relation to the Amended Common Fund Application;
and
 - (b) written submissions in reply in relation to the Amended Common Fund Application.
- 7 The Amended Common Fund Application be listed for hearing at 4:30 pm on 26 June 2018.
- 8 Orders 1-3 made on 29 May 2018 be vacated.

Referee

- 9 By 4.00 pm on 7 July 2018, the applicants file and serve any submissions in relation to:
- (a) whether to appoint a Referee to inquire and report on certain matters raised in the Further Amended Statement of Claim dated 9 April 2018;
 - (b) the scope of any such Reference;
 - (c) the powers to be granted to the Referee in the event that a Reference is ordered.
- 10 By 4.00 pm on 21 July 2018 the respondents are to file and serve any submissions in relation to:
- (a) whether to appoint a Referee to inquire and report on certain matters raised in the Further Amended Statement of Claim dated 9 April 2018;
 - (b) the scope of any such Reference;
 - (c) the powers to be granted to the Referee in the event that a Reference is ordered.
- 11 By 6 July 2018, the applicants confer as to the identification of an appropriate Referee to be appointed if an order for a Reference is made.
- 12 The matter be listed for a case management hearing at 4.30pm on 1 August 2018.
