THE COURT ORDERS THAT:

1. Subject to further order, proceedings NSD35/2018, NSD181/2020, NSD244/2021, NSD310/2021 and NSD498/2021 (**Related Proceedings**) be case managed together.
2. Pursuant to s 37P(2) of the *Federal Court of Australia Act 1976* (Cth), the legal representatives for the parties in the Related Proceedings are to confer before a Registrar of the Court for the purposes of identifying, and resolving to the extent they can be resolved, all interlocutory issues that need to be resolved in order to ready the Related Proceedings for a final hearing, including, but not limited to, identifying the topics of specialised knowledge in respect of which the parties think it is likely opinion evidence will be relevant to the resolution of the claims of the applicants and group members (**Conferral**).
3. The Conferral is to take place on a date to be fixed by a Registrar of the Court but no later than 28 July 2021.
4. By 2 August 2021, the parties are to provide a joint agenda document which identifies any matters requiring resolution by the Court arising from the Conferral or otherwise.
5. The Related Proceedings be listed for a further case management hearing on a date to be fixed in the week commencing 2 August 2021.
