BY CONENT, THE COURT ORDERS THAT:

1. Orders 2 to 5, and 8 of the orders dated 3 June 2016 be vacated.

3. Navman Wireless file and serve any interlocutory application for security for costs and any affidavits in support by 18 July 2016.
4. The First Respondent/Cross Claimant (**Precision Tracking**) file and serve any affidavit evidence in answer in respect of any application for access to Precision Tracking's documents by noon on 18 July 2016.
5. Precision Tracking file and serve any affidavit evidence in answer in respect of any application for security for costs by 9.30 am on 20 July 2016.
6. Navman Wireless file and serve its outline of submissions in chief in respect of any application for access to Precision Tracking's documents, not exceeding five pages, by noon on 21 July 2016.
7. Navman Wireless file and serve its outline of submissions in chief in respect of any application for security for costs, not exceeding three pages, by 4 pm on 21 July 2016.
8. Domino's file and serve its outline of submissions in chief in respect of any application for access to Precision Tracking's documents, not exceeding five pages, by noon on 21 July 2016.



9. Precision Tracking file and serve its outline of submissions in answer in respect of any application for access to Precision Tracking's documents, not exceeding ten pages, by 4 pm on 22 July 2016.
10. Precision Tracking file and serve its outline of submissions in answer in respect of any application for security for costs, not exceeding three pages, by 4 pm on 22 July 2016.
11. The parties email Robertson J's associate competing proposed short minutes of order in respect of the interlocutory applications clearly identifying which, if any, orders are agreed and which orders are in dispute by close of business on 22 July 2016.
12. The matter be listed for a hearing at 10.15 am on 25 July 2016 for a half day hearing.
