#### **BY CONSENT, THE COURT ORDERS THAT:**

1. Orders 4, 5 and 7 of the orders dated 31 March 2017 be vacated.
2. By 28 July 2017, each party file and serve its expert evidence with respect to liability and quantum.
3. By 11 September 2017, each party file and serve its affidavit evidence, including expert evidence, in answer with respect to liability and quantum.

#### **Interlocutory application relating to discovery etc**

4. Any interlocutory application relating to discovery, production of documents or inspection of the parties' respective systems be filed and served, together with supporting evidence and written submissions (limited to 5 pages) by each party, on or before 31 July 2017.
5. Any interlocutory application filed pursuant to Order 4 above be listed for a half day fixture at 9:30 AM on 7 August 2017.
6. Each party file any evidence and submission in answer (limited to 3 pages) not later than 3 business days before the date for hearing of the interlocutory application.



**Referral to mediation**

7. Pursuant to Part 28 of the Federal Court Rules, refer the proceeding to mediation, in the two weeks commencing 18 September 2017, with the mediator, the precise date, times and location to be determined by consultation between the parties.

**Directions hearing**

8. The matter is to be listed for a directions hearing at 9:30 am on Thursday 5 October 2017.

**Liberty to apply**

9. Liberty to apply on three days' notice.
