BY CONSENT, THE COURT ORDERS THAT:

1. List the matter for a pre-trial case management conference on Wednesday, 17 October 2018 at 9:30AM.

Court books

2. Domino's to provide a draft supplementary court book index consisting of additional documents filed since the adjournment of the hearing in November 2017 (the **Adjournment**) to the other parties on Wednesday, 3 October 2018, with comments to be provided by Precision and Navman on Thursday, 4 October 2018 and the parties to agree on the index by Friday, 5 October 2018.
3. Domino's is to provide supplementary court books in electronic format along with two printed copies for the Court and one printed copy for each of Navman and Precision by Tuesday, 9 October 2018.

Notice of witness required for cross-examination

4. The parties to provide notice of:
 - (a) any additional witnesses required for cross-examination; and
 - (b) any witnesses previously notified as being required for cross-examination who are no longer required,

by Friday, 12 October 2018.



Objections to evidence

5. The parties to provide objections to the evidence filed since the Adjournment by Friday, 12 October 2018, and counsel to confer with a view to resolving objections by Wednesday, 17 October 2018.
6. Any outstanding objections to the evidence filed since the Adjournment be sent to the Associate to Justice Robertson by 5PM on Thursday, 18 October 2018.


Submissions

7. Domino's and Navman to file and serve opening submissions in chief on the pleading amendments by 4pm on Wednesday, 10 October 2018. Submissions not to exceed 5 pages.
8. Precision to file and serve submissions in answer on the pleading amendments by 4 pm on Wednesday, 17 October 2018. Submissions not to exceed 5 pages.

Trial order

9. The parties exchange proposed trial timetables on or before Friday, 12 October 2018 and seek to reach agreement on a trial timetable before Wednesday, 17 October 2018.
10. An agreed draft or a draft timetable listing the points of disagreement be provided to the associate to Justice Robertson by 5PM on Thursday, 18 October 2018.
