### **ORDER**

#### **THE COURT ORDERS THAT:**

1. The matter be listed before a Full Court in the New South Wales Registry on 22 and 23 August 2019 for hearing of the appeal.
2. The hearing be listed based on an estimate of 1½ days.
3. The requirements of sections 4, 5 and 8 of Practice Notice APP2 be modified to the extent provided in orders 4 to 9 below.
4.
  - (a) By no later than 4:00pm on 5 July 2019 the appellant shall submit to the Registrar a draft, as agreed between the parties, of the part A index and the part B CRI for the Registrar's approval; and
  - (b) within two working days of the Registrar's approval of the draft indexes, the appellant shall file and serve on the respondents:
    - (i) the complete part A book with all documents indexed and ordered according to a unique tab number; and
    - (ii) a copy of the part B CRI.
5. By no later than 4.00pm on 8 July 2019, the appellant must file and serve on the respondents his:
  - (a) outline of submissions, such outline not to exceed 30 pages; and



- (b) chronology.
6. By no later than 4.00pm on 26 July 2019, the respondents must file and serve their:
    - (a) outline of submissions, such outline not to exceed 30 pages; and
    - (b) chronology.
  7. By no later than 4.00pm on 7 August 2019, the appellant must file and serve his outline of submissions in response to the respondents' submissions, such outline not to exceed 15 pages.
  8. By no later than 4.00pm on 14 August 2019, the appellant must:
    - (a) file 4 copies of Part C of the Appeal Book;
    - (b) serve on the respondents an appropriate number of copies of Part C of the Appeal Book; and
    - (c) file and serve on the respondents his list of authorities and legislation in accordance with Practice Note APP2 and the List of Authorities and Citations Practice Note (GPN-AUTH).
  9. By no later than 4:00pm on 15 August 2019, the respondents must file and serve their list of authorities and legislation in accordance with Practice Note APP 2 and GPN-AUTH.
  10. Liberty to apply on 3 days' notice.
