THE COURT ORDERS BY CONSENT THAT:

1. The Respondent is to file and serve a defence by 4.00 pm on 21 August 2015.
2. The Applicant is to file and serve a reply (if any) by 4.00 pm on 4 September 2015.
3. Evidence-in-chief shall be by way of affidavit, except with leave of the Court.
4. Any party seeking an order for discovery is to serve any list of suggested categories of documents for discovery by the other party by 4.00 pm on 18 September 2015.
5. The parties are to serve a response to any suggested categories of documents for discovery by 4.00 pm on 25 September 2015.
6. Any application for an order for discovery is to be filed and served by 2 October 2015.
7. The Applicant is to file and serve any affidavits of evidence-in-chief on which it intends to rely by 4.00 pm on 21 October 2015.
8. The Respondent is to file and serve any affidavits of evidence-in-chief on which it intends to rely by 4.00 pm on 2 December 2015.
9. The Applicant is to file and serve any affidavits of evidence-in-chief in reply on which it intends to rely by 4.00 pm on 16 December 2015.
10. The parties shall attend a mediation before a Registrar between 1 February 2016 and 29 February 2016.
11. The parties are to exchange any objections to evidence by 4.00 pm 21 days prior to the first hearing date.



12. The parties are to exchange responses to any objections to evidence by 4.00 pm 14 days prior to the first hearing date.
13. The Applicant is to file an outline of submissions of no more than 10 pages by 4.00 pm 14 days prior to the first hearing date.
14. The Respondent is to file an outline of submissions of no more than 10 pages by 4.00 pm 14 days prior to the first hearing date.
15. The Applicant must file, and serve, the required number of copies of its list of authorities and legislation no later than 4.00 pm 5 business days before the first hearing date.
16. The Respondent must file, and serve, the required number of copies of its list of authorities and legislation no later than 4.00 pm 3 business days before the first hearing date.
17. The matter be listed for hearing for 5 days commencing at 10.15 am on 30 May 2016 at Brisbane.
18. There be liberty to apply.
