THE COURT ORDERS THAT:

1. The hearing dates of 8, 9 and 10 June 2016 are vacated.
2. The applicant is granted leave to file the affidavit of Sharon Lee Morrish affirmed 8 June 2016.
3. On or before 4 pm on 9 June 2016, the applicant is to file, and serve on the respondent, the affidavit of Sharon Lee Morrish affirmed 8 June 2016.
4. The applicant is granted leave to file a second further amended reply, only for the purpose of replying to paragraphs 9(b) and 9(c) of the second further amended defence.
5. On or before 4 pm on 20 June 2016, the applicant is to file, and serve on the respondent, the second further amended reply.
6. On or before 4 pm on 27 June 2016, the applicant is to file, and serve on the respondent, any additional affidavits of Jonathon Graham Carr Morrish, James West Dawson and Ian Aldridge on which it intends to rely in relation to the question of whether Surf City Cranes Pty Ltd was the relevant employer (Employer Point).
7. Any application for the issuing of any subpoenas to produce documents is to be made by 8 July 2016.



8. All persons currently subject to a subpoena to give evidence:
 - (a) are released from the requirement to attend the Court on 8, 9 and 10 June 2016;
and
 - (b) are required to attend on the relisted hearing dates as notified by the issuing party.
9. By 4 pm 14 days prior to the first hearing date, the applicant is to file, and serve on the respondent, an outline of submissions in relation to the Employer Point.
10. By 4 pm 7 days prior to the first hearing date, the respondent is to file, and serve on the applicant, an outline of submissions in relation to the Employer Point.
11. The matter be set down for hearing in relation to evidence on 15, 16, 17, 18 and 19 August 2016 commencing at 10.15 am on each day, except on 16 August 2016, when the hearing will commence at 2.15 pm at Brisbane.
12. The matter be listed for hearing in relation to closing submissions at 10.15 am on 2 September 2016 at Brisbane.
13. Costs are reserved.
