THE COURT ORDERS BY CONSENT THAT:

Defence

1. By 4 pm on 29 June 2018, the respondent file and serve a defence to the amended statement of claim.
2. By 4 pm on 27 July 2018, the applicant file and serve any reply to the defence to the amended statement of claim.

Lay Evidence

3. By 4 pm on 21 September 2018, the applicant file and serve any lay affidavits on which it intends to rely at trial.
4. By 4 pm on 12 October 2018, the respondent file and serve any lay affidavits upon which it intends to rely at trial.
5. By 4 pm on 26 October 2018, the applicant file and serve any lay affidavits in reply.

Agreed maps

6. On a date to be agreed, but no later than 26 October 2018, the parties are to agree on a book of maps, in A3 hard copy form and soft copy form, for use at trial.



Expert evidence

7. By 4 pm on 7 December 2018, the applicant file and serve any expert evidence upon which it intends to rely at trial.
8. By 4 pm on 21 December 2018, the respondent file and serve any expert evidence upon which it intends to rely at trial.
9. By 4 pm on 18 January 2019 the parties are to inform the Court whether they consider there is utility in either a joint experts' report or concurrent evidence or both.
10. By 4 pm on 18 January 2019, the applicant file and serve any expert evidence in reply upon which it intends to rely.

Objections

11. By 4 pm on 8 February 2019, parties are to file a joint note on any outstanding objections to evidence which require a ruling.

Court Book

12. By 4 pm on 1 February 2019:
 - (a) the parties are to confer and agree upon the contents of the court book; and
 - (b) the applicant file and serve an agreed court book index.
13. By 4 pm on 7 February 2019, the applicant file with the Court and serve an electronic copy of the court book with a hyperlinked index in text-recognisable PDF format.
14. Subject to further order of the Court, a document included in the court book:
 - (a) shall not form part of the evidence at the trial unless specifically tendered and admitted into evidence; and
 - (b) shall be treated as tendered and admitted if referred to at trial and no objection is taken.

Outlines of Opening Submissions

15. By 4 pm on 11 February 2019, the Applicant file and serve its outline of opening submissions.
16. By 4 pm on 15 February 2019, the Respondent file and serve its outline of opening submissions.
17. By 4 pm on 15 February 2019, the parties file a trial timetable.
