THE COURT ORDERS THAT:

1. The case management hearing at 9.30am on 4 August 2022 be vacated.
2. By 4.00pm on 5 August 2022, the applicant file and serve any outline of submissions in relation to the applicant's interlocutory application dated 29 July 2022 (the **Application**), such outline not to exceed 10 pages and to be double spaced, in 12 point font, and without footnotes (any references are to be contained in the body of the submission).
3. By 4.00pm on 2 September 2022, each respondent file and serve:
 - a. any evidence in response to the Application; and
 - b. an outline of submissions in relation to the Application, such outline not to exceed 10 pages and to be double spaced, in 12 point font, and without footnotes (any references are to be contained in the body of the submission).
4. By 12.00pm on 4 August 2022, the solicitors for the first and second respondents serve a copy of these orders on any person it has been informed is considering making an application for leave to intervene or to be heard in relation to the Application, together with a request that such person file and serve by 2 September 2022:



- a. any application that person makes;
 - b. any evidence that person relies upon in relation to (i) any application made and (ii) the Application; and
 - c. an outline of submissions in relation to the application that party makes and in relation to the Application, such outline not to exceed 10 pages and to be double spaced, in 12 point font, and without footnotes (any references are to be contained in the body of the submission).
5. By 5 September 2022, the applicant file and serve an outline of submissions in reply, such outline not to exceed 5 pages in length and to be double spaced, in 12 point font, and without footnotes (any references are to be contained in the body of the submission).
6. The matter be re-listed for a case management hearing, the hearing of the Application and the hearing of any application as contemplated by Order 4(a) of these Orders at 10.15am on 7 September 2022, that hearing to be conducted in person unless alternative arrangements are agreed between the parties and any person making an application contemplated by Order 4(a) and approved by the Court.
