
THE COURT ORDERS THAT:

1. The applicant be granted leave under R 10.24 of the *Federal Court Rules 2011* (Cth), instead of serving the originating application and statement of claim in accordance with R 8.06 of the *Federal Court Rules 2011* (Cth), to effect service on each of the respondents named in Annexure JWP-3, JWP-4 and JWP-5 of the affidavit of James William Parkinson dated 5 October 2015, except Mark O'Connell, Paul Brown and Dean Elliot, by:
 - (a) leaving a sealed copy of the originating application and statement of claim with the occupant of the premises located at the addresses listed in Annexure JWP-5 which corresponds to the relevant respondent, along with a copy of the letter set out in Annexure JWP-9;
 - (b) sending the text message set out in Annexure JWP-11 to the mobile number listed in Annexure JWP-7 which corresponds to the relevant respondent;
 - (c) sending an email which attaches the originating application, statement of claim and the template letter set out in Annexure JWP-9 to the email address listed in Annexure JWP-7 which corresponds to the relevant respondent;
 - (d) causing a notice to be published in the "Public Notices" section of the West Australian Newspaper in the form contained in Annexure JWP-10, with the names Mark O'Connell, Paul Brown and Dean Elliot removed;



- (e) making a copy of the originating application and statement of claim available for collection by each of the respondents at the office of the solicitors for the applicant between 8am and 6pm on each ordinary working day for a period of 10 business days from the date on which the notice in Annexure JWP-10, with the names Mark O'Connell, Paul Brown and Dean Elliot removed, has been published in the West Australian Newspaper; and
- (f) further, in the case of all such respondents, sending by prepaid post the originating process, statement of claim and the template letter set out in Annexure JWP-9 to each respondent at their last known residential address.
2. The applicant take the steps in order 1 to effect service by 28 October 2015.
 3. Subject to compliance with orders 1 and 2, service be taken to have been effected under R 10.24 of the *Federal Court Rules 2011* (Cth) on 29 October 2015.
 4. The respondents file and serve any defences by 29 November 2015.
 5. The applicant file and serve any reply by 14 December 2015.
 6. The matter be listed for a further directions hearing on 4 January 2016 at 10.15am.
