THE COURT ORDERS THAT:


1. Thirty-eight, Thirty-ninth, Fortieth, Forty-fourth and Fiftieth Respondent, by no later than 27 June 2016.

5. Subject to compliance with orders 2 and 3, service be taken to have been effected under R 10.24 of the *Federal Court Rules 2011* (Cth) on 28 June 2016.
6. The Third, Sixth, Seventh, Eighth, Twelfth, Fourteenth, Twenty-first, Thirty-fourth, Thirty-eight, Thirty-ninth, Fortieth, Forty-fourth and Fiftieth Respondents shall file and serve any defences by 25 July 2016.
7. The matter be listed for a directions hearing on 26 July 2016 at 10.15am.
